ORDINANCE NO. 50⁴

AN ORDINANCE OF THE TOWN OF DE BEQUE, COLORADO, repealing §7.04.110, and amending §7.04.120 of the De Beque Municipal Code

WHEREAS, The Town believes that the regulation of weeds, rubbish, and trash is vital to the community, and

WHEREAS, The Town publicly publishes the Municipal code, both in written form and digitally online, and

WHEREAS, It is not necessary to re-publish notice of the Municipal Code as outlined in the sections listed above at the Town's expense, causing further delay and administrative costs.

THEREFORE, the Town of De Beque Board of Trustees hereby amends Chapter 7.04 of the De Beque Municipal Code as follows:

1. §7.04.110 is repealed
2. §7.04.120 (A) is amended as follows:

1. The first sentence of Section 7.04.120(A) is amended as follows:

~~A. In addition to the annual Notice provide for in Section 7.04.120 of this Chapter, and any time after such annual Notice is published, an~~
BEFORE ANY FINE OR OTHER LIABILITY IS IMPOSED PURSUANT TO THIS CHAPTER 7.04, AN authorized representative of the Town shall notify in writing the owner or owners of property, his agent or any person having charge of such property, that a violation of THIS CHAPTER ~~their duty to remove any accumulated refuse from such property or to cut all weeds and/or brush and to remove the same from the property~~ has occurred. **This notice shall be satisfied by the issuance of a summons prior to any fine or other liability being imposed.**

2. Section 7.04.120(A)(1)(d) is amended as follows:

(d) the date and time by which the violation must be remedied, WHICH SHALL NOT BE LESS THAN FIFTEEN (15) DAYS FROM THE DATE

OF THE NOTICE OF VIOLATION.

3. Section 7.04.120(C) is amended to increase the fee for the costs of collection, supervision and inspection from 5% to "up to the maximum allowed by statute"

Effective Date. This Ordinance shall become effective thirty (30) days after publication pursuant to C.R.S. § 31-16-105.

THIS ORDINANCE NO. 504 was adopted by the Town of De Beque Board of Trustees by a vote of 7 to 0 on the 3rd day of March, 2020.
